What is this product?

Type:

This product is a share class of Asia Sustainable Future Fund (the "**Sub-Fund**"), a sub-fund of Matthews Asia Funds (the "**Fund**"). The Fund is an undertaking for collective investment in transferable securities organised as a public limited company and qualifying as an investment company with variable capital with multiple sub-funds. The performance of this product will depend on the performance of the portfolio of investments of the Sub-Fund, as further described in the section "Objectives" of this document.

Term:

This product has no maturity date. It can be terminated by the PRIIP Manufacturer and liquidated in the cases set out in the prospectus and the articles of association of the Fund.

Objectives:

This product seeks to achieve long-term capital appreciation while investing in companies that contribute to a sustainable future by investing primarily (i.e., at least 65% of its net assets) in equities of companies located in, or with substantial ties to, the Asia ex Japan region that the Investment Manager believes contribute positively to one or more of its sustainability focus areas. 


